Student-Friendly FAQ

What is the 30 Credit Hour Standard?

The 30 Credit Hour Standard at Cuyahoga Community College (Tri-C®) encourages students to graduate within two years by completing 30 credit hours each academic year. The program provides a 50% tuition waiver for credits up to 12 during the summer term.

Who is eligible for this program

- New or transfer students with fewer than 12 college credits who begin in the fall semester (starting Fall 2017) must meet the following eligibility requirements:
 - Complete at least 30 or more credit hours in a three-semester (fall, spring and summer) academic year
 - Maintain consecutive enrollment each semester throughout the year, including summer term
 - Earn a satisfactory grade for pass/fail classes or a grade of C or higher for all graded classes
 - Declare or reaffirm a program of academic study
 - Accumulate fewer than 90 credits
 - Complete a Free Application for Federal Student Aid (FAFSA) form at fafsa.ed.gov
 - Maintain a cumulative GPA of 2.0 or higher
 - Sign a 30 Credit Hour Standard Program Agreement Form

How does a student receive this tuition waiver?

The summer tuition waiver will appear on a student's account at the start of the summer session and become effective after the last day to withdraw.

How much is the waiver?

The tuition waiver is equal to 50% of paid tuition for every credit hour enrolled in the summer term up to 12 credit hours.*

How and where do I sign the agreement?

The agreement form is located on my Tri-C space. Search for Tuition Incentive Programs on the Discover page to find the 30 Credit Hour Standard program agreement. Upon signing the form, students will receive a confirmation email.

Can a student enroll in more than one tuition incentive program?

Students can enroll in either the 15+ Perks Program or the 30 Credit Hour Standard. Tuition Guarantee accompanies both incentive programs.

*Contingent upon the approval and continued authorization of this tuition waiver by the Ohio Department of Higher Education (ODHE) and the Tri-C Board of Trustees.
